Includes annual review of documents, inspection & report preparation (up to 6 hours), report review and related certification costs (eg derogations, certificates). Payable prior to inspection. Inspection travel expenses invoiced at cost after inspection.

Additional inspection/sampling after non-compliance	At cost	Unannounced inspection where major non-compliances are found/any additional inspection as a result of those non-compliances/residue testing after non-compliance.
Pre-printed transport declaration book	\$35	Plus postage (currently \$18).
Group certification	Ask for a quote	Includes NFP, community gardens, market gardens, schools
