In order to assess compliance to the National Standard for Organic and Bio-Dynamic Produce and meet regulatory requirements, OFC needs to share your information to other parties involved in OFC's compliance and certification activities.
OFC may use and disclose your personal information for the primary purpose for which it is collected. OFC may also use and disclose your personal information for reasonably expected secondary purposes which are directly related to the primary purpose and you would reasonably expect us to use the information for this secondary purpose. Otherwise OFC will not disclose your personal information unless the conditions of the Australian Privacy Principals are met, for example you have consented to the use or disclosure; or the use or disclosure is required or authorised by law.
A reasonably expected secondary purpose includes audits conducted on OFC for the purpose of accreditation of OFC by domestic and international agencies, including but not limited to the Australian Department of Agriculture, Fisheries and Forestry (DAFF) and Joint Accreditation System of Australia and New Zealand (JAS-ANZ).
From time to time OFC are required to disclose information to others on your behalf.
